Obligations of the administrator of the guarantee registry

As the administrator of the guarantee registry, the Electrical Contractors' Association (STUL) shall commit to maintaining an up-to-date registry, which is accessible for free online, and to publish an STUL guarantee registry (= a list of companies under the STUL guarantee registry) no less than four (4) times per year in the Sähkömaailma magazine. The guarantee registry is also appended to the information folders (Electricity and Security industry) of Sähköinfo oy. STUL shall also deliver the registry by mail or fax upon request. A general description of the contents of the STUL guarantee shall also be included in the publication of the guarantee registry. STUL shall also inform other associations in the construction industry about the guarantee system, including the Finnish Association of Building Owners and Construction Clients, the Confederation of Finnish Construction Industries RT and planning organisations.

STUL shall provide the company issuing the guarantee with an STUL guarantee certificate, which the company may duplicate and use freely in its business and marketing activities.

Sähköinfo oy is responsible for the technical administration of the registry. The STUL guarantee and certificate shall be provided free of charge to the issuer of the guarantee.

Validity of the guarantee

The company issuing the warranty shall be able to terminate the guarantee with a written notice of termination pursuant to the six-month (6) termination period.

STUL shall have the right to revoke the certificate related to the guarantee and to remove the company from the guarantee registry immediately if the company fails to adhere to the conditions of the guarantee. Prior to the revoking of the certificate and the removal from the registry, STUL shall notify the company in writing and allow the company an opportunity to issue a response.
